#### **Termination of Lessons:**

Commitment for minimum of one month is required. Minimum 30 days notice is required for discontinuing lessons.

#### Attendance and absences:

Regular attendance at lessons is necessary and expected. All absences must be notified as soon as possible (preferably minimum 24 hours) Absences are nonrefundable.

## Preparation for lesson:

Students must arrive to sessions on time (arrive 5 minutes before assigned time); the lesson will finish at the scheduled time. Students are required to have their student kit for every class session. Student Piano Kits can be purchased through L4C Multimedia for \$500 (Student Piano/keyboard, Stand, Sustain, Seat, headphone). Students are required to have a binder or notebook and pencil for note taking. Bring all piano gear including assignment book to lesson always to sessions.

#### **Practice Time:**

Students must schedule a regular daily practice time at home on their own schedule. **RECOMMENDED:** Minimum of 3 - 5 practices per week; Minimum of 5 Hours per week (**HOME**). All Students are required to engage in a minimum of 30 minutes practice during class sessions; for the instructor to observe playing habits and progress.
